- Handwritten cover letter (maximum 2 pages), dated and signed by the student in which you will explain your reasons for applying for a grant and the obstacles you have to overcome to finance your studies at the Institut Paul Bocuse
- Estimated annual budget (use attached template) + copy of supporting documents relating to the budget
- Personal identification recto-verso
- Copy of the family record book of your parents or legal guardians
- Photocopies of diplomas already obtained
- Transcripts:
 - For students in their final year: transcripts of the first 2 quarters of the final year*
 - For others: transcripts for the last 2 years
- For divorced parents, copy of the decree mentioning the parent who is in charge of the student and the amount of the alimony
- Last tax notice of the parents and, if applicable, that of the student
- For foreign parents, sworn statement of the amount of income received - with the equivalent in euros
- Proof of school attendance of dependent children
